This is in response to your April 28, 2010 Freedom of Information Act (FOIA) request for certain litigation statistics relating to Title VII of the Civil Rights Act of 1964. Your request was received in my office on May 7, 2010.

In responding to your request, I directed your request to our information technology office and asked that they create a report of the subject litigations responsive to your request. The information herewith provided is the closest by category that we could identify from our CASES database system. The CASES database is our case management control system in which we keep all records of litigation cases.

If you are dissatisfied with my action on your request, you have a right to appeal to the Director, Office of Information Policy (OIP), United States Department of Justice, 1425 New York Avenue, NW, Suite 11050, Washington, DC 20530-0001. See 28 CFR § 16.9 (2008). Please note that your appeal must be received by OIP within sixty calendar days of the date of this letter or it will be untimely. Thereafter, judicial review would be available in the U.S. District Court in the district in which you reside or have your principal place of business or in which the agency records are situated or in the United States District Court for the District of Columbia.
